

COMFORT DENTAL JUNIOR STARTING LINEUP – RULES 2017

Official Rules

- 1. HOW TO ENTER:** Fill out an entry form at www.comfortdental.com. All entry forms will be collected by the Comfort Dental corporate office, and Winners will be drawn from all eligible entries.
